GENERAL STATEMENT OF DUTIES: Assist in planning and carrying out a daily program designed to meet the physical and developmental needs of a group of children. This person must be sensitive to the needs of individual children and relate well to both the children and adults. Bilingual in English and Spanish, a plus but not necessary

Responsibilities

- Assist in planning, scheduling and implementing the daily program of appropriate developmental experiences for a classroom group of children
- Provide care and protection for assigned children
- Maintain a physical environment conducive to children's growth and development and arrange to promote optimal program functioning.
- Consider and provide for the needs of the individual in relationship to their cultural and socioeconomic background, emotional or physical handicaps and individual style and pace of learning.
- Respect the dignity and basic rights of each child
- Help children learn to adapt to and cope with real-life situations; to develop appropriate habits in such activities as eating, dressing, napping and personal hygiene
- Make daily observations of the health of children, reporting conditions which require attention
- Assist in the maintenance of progress records on the emotional, physical, social and intellectual development of assigned children
