Position Summary:

The Assistant Cook shall perform the general duties under the supervision of the Director, and when assigned to food service responsibilities, under the supervision of the Cook. The Assistant Cook performs functions related to housekeeping, food service, and maintenance and distribution of supplies. In addition, the Assistant Cook will accept training related to food preparation and cooking so that he or she may substitute for the Cook as needed. The position also requires flexibility to support food service operations across multiple sites as needed.

Responsibilities

Responsibilities?

- Assist Cook in preparing food, as needed.
- Arrange tables for lunch and snack times, in accordance with the needs of the children's groups.
- Distribute dishes, cutlery, and food to children.
- Clean prep areas before and after meal and snack times.
- Wash dishes and utensils according to sanitary practices.
- Remove kitchen garbage to outside receptacles and clean containers.
- Assist in maintaining inventory of food and utensil supplies.
- Provide coverage and support at multiple sites, as needed, to ensure continuity of food service operations.
- Additional duties as assigned by Educational Director.
